## "THE SINS OF THE FATHER BEING PLAYED BY THE SINS OF THE CHILDREN" MACEDONIANS, HELLENES AND DIASPORA



## A response to "Who in this celestial world gave the Greeks the right to take away the Macedonian language"

The sins of the fathers are being played out again by the actions of the children who should know better. It is a huge pity that we are instilling in our children our sins and those of our ancestors in order to keep issues that are inclined to inflame passions and rise to further negative actions within our society. **Clever neo pseudo Macedonian state (FYROM) marketing.** In 2011 when the drama was played in court recently regarding the inflammatory remarks by the writer of the article "Who in this celestial world gave the Greeks the right to take away the Macedonian language" is but another stunt and provide a platform to those support the idea of a neo Macedonia based on Slavic designs.

The writer Gandeto who wrote the article on the 14 May 2009 was well aware that his article would cause passions to rise, especially amongst those of Hellenic background and one thinks that it was created deliberately to create additional controversy and keep their issues in the public arena. One must acknowledge the clever thinking by these writers such as Gandeto and those from the neo pseudo Macedonian state (FYROM) in marketing their product of controversial issues.

Back in 1991 and 1992 when one thinks about the issues at stake then, taken from a rational and emotional intelligent point of view, there was no need for this type of drama to be played out publicly and/or behind the scenes and one wondered at the time whether these were hidden agendas by both protagonists. An interesting point as discussed above, events and anecdotal evidence proved that this was the case for some who apart from personal endeavours sought compensation, insurance frauds, political aspirations, flying the banner so to speak and foolishly at that.

**Political intervention.** One must admit that Jeff Kennett at the time did more for the Hellenic cause by acknowledging Alexander as Hellene and that Macedonia was Hellenic rather than belonging to the neo pseudo Macedonian state (FYROM) cause. Jeff Kennett whether you support him or not and despite any faults he may have had, was an astute and wise counsellor in these matters and brought some semblance of peace between the two protagonists.

Despite the serious of the issues at stake and the inflamed and at times passionate response from the two parties, it was a joke then and it is still considered a joke now after so many years. Churches were being allegedly been vandalised, posters all over the place, hate mail and vile remarks to and from both parties in the various media outlets at that time.
