- to break, enter and search any "building, receptacle or place" specified or described in this warrant for any thing of any kind described in this warrant,
- AND
- to bring the thing before the Court so that the matter may be dealt with according to law,
- AND
- to arrest any person apparently having possession, custody or control of the thing

I am satisfied that there are reasonable grounds that the thing namely

is seized properly within the meaning of the Confiscation Act 1997 and I direct that the applicant hold or retain the thing as if it were seized under section 73 of the Confiscation Act 1997 as and from the date when the property is so seized.
